

Popeye Motor Launches

Terms & Conditions



1. Maximum Numbers

1.1 The Venue has a total capacity of 50 people, per boat.

2. Confirmation and Deposit

2.1 Popeye Motor Launches does not accept tentative bookings. All reservations must be accompanied by a \$250.00 deposit (Bond), per boat and a completed Terms and Conditions form.

2.2 Popeye Motor Launches reserves the right to cancel any reservation not accompanied by a deposit.

3. Unforeseen Circumstances

3.1 In the unlikely event of inability to comply with any of the provisions in this contract by virtue of extreme weather conditions, equipment failure, other unforeseen contingency or accident, the venue reserves the right to cancel any booking, and refund deposit paid, at any time.

4. Cancellation

4.1 All cancellations must be made in writing, addressed to the Proprietor.

4.2 Deposits paid are refundable up to 14 days prior to the function date.

4.3 After 14 days prior to the function, or in the case of non-arrival, cancellations shall forfeit all monies paid, and the venue reserves the right to charge for the number of boats confirmed.

5. Pricing

5.1 All prices quoted are exclusive of Goods and Services Tax (GST). Please add G.S.T to all costs (except the security/deposit charge)

6. Payment

6.1 Popeye Motor Launches accepts payment via business cheque, credit card, EFTPOS, cash or electronic bank deposit.

6.2 Personal cheques will only be accepted by prior arrangement with the Proprietor.

7. Entertainment

7.1 Popeye Motor Launches reserves the right to approve all musicians, bands, DJs and other forms of entertainment prior to the function.

7.2 The Hirer agrees to control volume levels of entertainment at all times to ensure there is minimal impact on nearby venues.

8. Liability

- 8.1 The person named as Client/Company shall be responsible in full for all costs and charges as a result of the agreed reservation.
- 8.2 The Client/Company shall be liable for any damage sustained to the Popeye Motor Launches venue by the Client/Company and guests, agents for or other persons associated with the function, whether in the boat allocated for the function or any other area of the landing etc.
- 8.3 Popeye Motor Launches and its employees or agents will not be liable for any injury, damage or loss of any nature, however caused (through negligence or not), suffered by the Client/Company or guests, agents for or other persons associated with the function, whether before, during or after the function. Public Liability insurance is the responsibility of the Hirer.

9. Alcohol consumption and/or sale

- 9.1 Popeye Motor Launches must hold a liquor licence for all events/functions that serve or sell alcohol. This will require the application for and payment of a liquor licence with the Consumer and Business Services of SA. The application will be completed by Popeye Motor Launches on behalf of the Hirer. Application must be completed 14 days prior to event or a late application fee will be charged.
- 9.2 All B.Y.O bookings will have a service charge of \$200 payable to Popeye Motor Launches. Alcohol will only be permitted on board the Popeye when the liquor licence required is obtained and held by Popeye Motor Launches and the Hirer has paid fee.
- 9.3 The sale of alcohol on board will remain the right of Popeye Motor Launches, and the alcohol and prices for such will be selected in negotiation with the Hirer.

Popeye Motor Launches reserves the right to alter any of the aforementioned conditions at any time.
